5. A committee should be constituted for proper checkup with the members of both Teaching and Non-Teaching staff for proposed work of demolishing.

place.

Hence, It is to request the department to give consent for demolishing the

existing old dilapidated Block and issue a No-objection certificate for

construction of New building in the same place for the benefit of student

community as it is a Govt College and stakeholders are mostly from

marginalised and weaker sections of the society to pursue higher education.
