POLICY DOCUMENT FOR SCHOLARSHIPS AND FREESHIPS

The college believes that the additional financial assistance will boost up the confidence level of student. The financial assistance like scholarships and freeships make the student, who is particularly from socially, culturally, economically backward sections responsible and accountable for the assistance. Since this is a Government College located in rural area, most of the students are from above said backward sections. Hence, they compulsorily require financial assistance. So, the college tries to tap this type of financial assistance from all possible means. This significant financial assistance is from Government of Andhra Pradesh itself. More than 90% of students are being benefitted from the Government Schemes such as scholarships etc. At the commencement of every year, with the help of student-mentor system, college identifies the beneficiary students who are eligible for the schemes of the Government. An awareness program is conducted for the first year students to enlighten them how to grab these benefits. Through number of circulars, we alert the students who apply for these scholarships. We see that 100% of all eligible students will get these benefits by continuous follow-up. Coming to these Government scholarships, the CM of Andhra Pradesh launched the new scheme on the 27th of November 2019 known as 'Vidya Deevena Scheme' earlier known as 'Fee reimbursement'. It is a student education sponsorship program. This YSR Jagananna Vidya scheme will help the financially poor children who are pursuing or going to pursue their college studies.

The disbursal of scholarship benefit is categorised into two schemes;

- (a) Jagananna Vidya Deevena (RTF): to provide full fee reimbursement to every eligible student, i.e. Full Fee (Tuition Fee, Special Fees, Other Fees & Exam Fees) as defined in the G.O.Ms.No.66 SW(Edn) Dept., dated 8-9-2010 and as fixed by the competent authorities is reimbursed to all eligible students. ii. Full fee shall be credited to the respective College accounts on behalf of students.
- (b) Jagananna Vasathi Deevena (MTF): to provide Rs.20,000/- per person for Degree and above courses per year to every eligible student for food and hostel expenses. Jagananna Vasathi Deevena shall be credited into the respective account of the mother of the eligible student. In case of the demise or absence of the mother, the amount shall be credited to the account of the natural guardian of the student.

Coming to aids from NGO's, college adopted to tap all kinds of assistances from NGO's. For example, this year college was donated a wheel chair for physically handicapped students by Rotary Club, Tanuku. Two students who got admission in Central University of Andhra Pradesh, were given financial assistance of Rs. 7,500/- each from Manavatha, Tanuku. (An NGO).
