In the meeting convened by the Commissioner of Collegiate Education, A.P Vijayawada on 20th July 2022 at SRR & CVR Govt. Degree College, Vijayawada with Regional Joint Director of Collegiate Education, certain Principals of Govt. Degree Colleges and Administrative Staff of the Dept, in the reference 6th read above, the Principals of Govt. Degree Colleges have represented, suggesting certain amendments/modifications to the guidelines issued to the reference 3rd read above. After elaborate thorough examination of the representations, it has been decided to make certain amendments to the Guidelines.

In exercise of the powers conferred by the proviso to the Rule 11.0 of the Guidelines for the College Planning and Development Council (C.P.D.C), the Commissioner of Collegiate Education hereby made the following amendment to the guidelines for the C.P.D.C.

Amendment-V

Under Rule 7.1 FUNDS OF THE C.P.D.C: from donations from members and donations, gifts and contributions received from the individuals, associations, firms, trusts, companies and registered bodies, the words “ **Parents of the students of the College**” shall be added. Due receipts are to be issued and records are to be maintained.

The above amendments to the guidelines for the C.P.D.C shall come into force with immediate effect.

All the Government Degree College Principals are requested to place the matter before the C.P.D.C, members on collection of the donations from the parents of the students of the College and make proper resolutions to this extent and make proper entries in the minutes of the book with proper attestation of the members of the C.P.D.C

Further the Principal's of the College may be requested to take all necessary steps in achieving the objective of the College Planning & Development Council (C.P.D.C.) by **conducting the meeting at least one in every two months to set the goals to be achieved and also to review the progress of the already set goals.**
